#### **CALL TO ORDER**

Board member, Dr. Timothy Ford, called the meeting to order at 12:31 p.m.

### **NEW BUSINESS**

- The board discussed KRS 311.450 and extending 2023 Podiatry renewals. A motion was made by Timothy Ford to extend 2023 Podiatric license renewals until 2/29/2024. Paul Krestik seconded the motion and the motion carried.
- The Board Administrator notified the board that the department is working on having IT create a late renewal automated correspondence to be sent to Podiatrists who miss the June 30<sup>th</sup> renewal date annually.
- The board discussed SB 28 and an update for fulfilling the lobbyist invoice for the work Capital Solutions completed assisting the board with the drafted bill. Courtney Cook, Operations Section Supervisor, explained to the board that a legislative claim would have to be submitted by 1/12/2024 for the invoice to be paid and that the board counsel would need to draft a CAP report for that claim due to an RFP not being completed prior to the lobbyist group being hired to assist with the bill. The board discussed approaching KPMA to potentially assist with the invoice for the lobbying groups work. A motion was made by Dr. Ford for board counsel to complete the CAP report so the legislative claim could be submitted by the deadline. Dr. Krestik seconded the motion and the motion carried. A motion was made by Dr. Ford for Dr. Krestik to approach KPMA about potentially assisting with the invoice for the lobbying group work. R. Neil Lively seconded the motion and the motion carried. All other SB 28 and lobbyist invoice updates were tabled until the April 12, 2024, board meeting.
